Digital Economy Program is now accepting applications and will remain open until March 2023. To be eligible for the Digital Economy Program, businesses must fit the following criteria:

- registered in Alberta;
- zero to 49 employees (this includes self-employed business owners with no employees); and,
- home-based or commercial business.

Non-profits, charitable trusts, and franchises are not considered eligible businesses under this program.
